However, since it is a self-study course students are able to complete the program before the allowed time frame. The suggested time frame for completion is 12-15 months. This diploma program offered by Lakewood College is accredited by a national accrediting agency recognized by the Department of Education, which is the Distance Education Training Council. Upon completion of this diploma program, spouses are eligible to sit for the Certified Legal Assistant (CLA) Examination with the National Association of Certified Legal Assistants & Paralegals.
